ARTIST AGREEMENT

The purpose of this agreement is to outline the guidelines that will apply to the art exhibit from

January 1, 2021 through DECEMBER 31, 2021

Art work **MUST** be set up between January 1, 2021 and February 15, 2021. Any art work currently on display that is not/cannot be renewed must be removed no later than **February 15, 2021** unless other arrangements are made in advance with LCAT/JEDC. Artwork can be renewed for one year only. Artwork not picked up by February 15, 2021 will be charged a \$15 per month storage fee and will be stored in the City Barn.

The artist agrees to be responsible for installation and removal of their art work and any cost associated with shipping or transportation of the art work. The LCAT/JEDC is open to the public therefore the artist certifies that his/her works(s) are soundly and professionally constructed on durable and sturdy materials, have no breakable or easily damaged parts or pieces, are suitable for outdoor public display, are constructed in a way which will not cause safety or liability problems and will require no maintenance during the (12) twelve-month exhibit period.

All art work must be for sale. Each sculpture must be a minimum height of 3' (three feet) tall. In the event a piece of art work is sold during the (12) twelve-month exhibit period, the artist agrees that LCAT/JEDC will receive **25%** of retail price for commission. The process of the sale of the Art work will be done by the LCAT/JEDC and the Artist will be paid **75%** of retail price within Sixty (60) days of the sale. All art work shall remain in place for a **(12) twelve-month exhibit period**. If the Artist's art work is sold during the (12) twelve-month exhibit period then the Artist can replace it with a similar one immediately upon approval.

The Artist will coordinate delivery of art work with the purchaser. The LCAT/JEDC will provide the Artist with purchaser contact information within one week of purchase.

No art work will be removed during the term for private sales without commission being paid to LCAT/JEDC.

The LCAT/JEDC will do everything possible to safeguard an artist's property, however, it's insurance will not cover art work that is not owned by the facility, it will be the Artist's responsibility to furnish insurance on their art work. Therefore, this document serves as a Waiver of Liability when exhibiting in the City of Jewett, Texas.
